For 2019 we trialled new venues. Initially we were offered the meeting room at the Telethon Kids Institute inside the new Perth Children's Hospital. Unfortunately, we were unable to continue there due to a change of hospital policy and have now moved to The Boulevard in Floreat. We have had some challenges with seminars this year mostly due to IT issues, and although Ross Horley has used all his magical powers, we have occasionally been unable to link in our country colleagues. We do not accept this as good enough and if we experience any further IT difficulties we may look to return to the SJOG venue. Through the use of videoconferencing we are able to bring you professional presenters from not just Australia but internationally. These seminars are not possible for us to host without the magnificent support and expertise provided by Ross. Please can I ask you to show our appreciation with a huge round of applause for Ross.

During 2019 we tried two ways of increasing our seminar attendance. The first seminar of the year with Dr Vincent Smith was offered for free and wow did we have an unexpected registration of over 100 people. Not all arrived on the night, but we did have a room full of people. During Infant Mental Health Awareness Week, we offered members the opportunity to bring a friend for free and we had about 20 non-members join us.

The other key work that has been happening for WA Branch this year is the Endorsement Implementation Project supported by the Competencies Guidelines and Endorsement Working Group. Congratulations to Anne Lowagie, our Project Coordinator, Rochelle Matacz and Gally McKenzie for their passion and drive of the Endorsement Implementation Project. This small team have collaborated closely with the US Alliance for the Advancement of Infant Mental Health and been responsible for:

- extensive adaptations to the endorsement information and management system for the WA context
- training and organising training for the Endorsement Team members
- developing online and other information materials and
- engaging with stakeholders, including potential early applicants, partners and funders
- 46 expressions of interest (EOI) have been received from practitioners and workers
  across many disciplines in the IMH field with 13 AAIMH Members have indicated that
  are interested in applying for endorsement as soon the system is available

The work is ongoing and we are hopeful of further funding to see the project through. For now I extend a huge thank you to the working Group Chairperson - Liz Oxnam and committee members Lloyd Fernandez, Raylene Lewis, Rochelle Matacz, Gally McKenzie, Lynn Priddis and Nicole Wade. This project is ambitious and exciting for Western Australia.

In 2019 our National body offered Indigenous Scholarships to assist with participation at the AAIMH National Conference in September. WA Branch supported this and had hoped to fund a local person to represent WA at the conference. Unfortunately to date we do not have any

applicants, but I hope the initiative will be considered again for future conferences. Applications now close tomorrow Friday 9 August 2019.

The Management Committee approved funding for a Reflective Reading Group pilot project to be facilitated by Sharon Cooke. I hope you all received your invitation by email this week and will consider applying to be part of this pilot group. Our country members are highly valued, and we are giving them priority, so they have the opportunity to grow their Infant Mental Health knowledge and practice in a supported way. We will be using Zoom Videoconferencing as the platform for country members to join the group. Please forward your Expression of Interest to Sharon before the 16<sup>th</sup> August 2019.

#### Now let's reflect on what is coming up for all of us.

I would like to acknowledge Gally McKenzie who is currently National Chairperson for AAIMH. It is an honour to have the National Chair be from WA. Congratulations Gally.

The Management Committee will hold a planning day on Saturday 12 October to set some goals for the new incoming committee. If you have ideas about what you want us to focus on, please have a chat with me tonight. I would be happy to have members attend the planning day if anyone is interested as we want members to be able have a say about what they would like.

We have the **2019 AAIMH National Conference** being held in Adelaide on the 4<sup>th</sup> to 7th September with the theme 'Our Infants - Infant Mental Health is a Public Health Matter'. Plus remember to put in your diaries for 7<sup>th</sup> - 11<sup>th</sup> June 2020 the WAIMH **2020 Brisbane Conference:** 'Creating stories in infant mental health: research, recovery and regeneration'.

2019/20 will be the year for the launch of the Endorsement process so please keep a lookout for this and express you interest with the team now.

We are currently in discussions with an international speaker to bring to WA in 2020 for training and for a seminar. I am going to keep the name a surprise for now but can say it will be someone you will want to meet. Further details will be released once we have dates confirmed.

Griffin Longley, CEO of Nature Play WA, will be our guest presenter for the October seminar and he will share his findings from his recent Churchill scholarship.

Thank you for allowing me the time to share my reflections with you tonight. I hope they have been of interest and just maybe given you some reason to think about coming onboard to join our committee. Together we can do more for the WA Branch and be advocates for the infants and their families we all support.
